Re: Demand to Cease Discriminatory Treatment of Penn State YAF in Connection With James Lindsay Event

Dear Ms. Oman,

The Center for American Liberty represents the Young America's Foundation ("YAF") and the Pennsylvania State University Chapter of Young Americans for Freedom ("Penn State YAF"), the local chapter affiliate of YAF. I am writing to inform you of unlawful treatment against Penn State YAF by Pennsylvania State University (the "University") regarding a planned event on campus next week and to demand that you remedy the situation without delay. **This demand requires your immediate attention to avoid litigation**. #### I. Factual Background

YAF's mission is to ensure "young Americans understand and are inspired by the ideas of individual freedom, a strong national defense, free enterprise, and traditional values." YAF has chapters at colleges across the country.

Penn State YAF is a properly Registered Student Organization ("RSO") with the University. Penn State YAF advances its mission by, among other things, inviting influential speakers to campus to discuss pressing issues of the day. This dispute involves one of these events.

On Thursday, November 16, 2023, Penn State YAF is hosting nationally renowned speaker and author James Lindsay on campus from 7:00-8:00 p.m.<sup>2</sup> The purpose of the event is to expose students and members of the public to robust discussion about topical social and political issues. Penn State YAF anticipates the event will attract approximately 50 attendees. Tickets are not required, and the event is open to the public.<sup>3</sup>

The University informed Penn State YAF that the only venue available for the event was the Bryce Jorden Center ("BJC"), which is on the far edge of campus—away from where students typically congregate. Upon learning of this location, Penn State YAF chapter president Jack Kentner emailed Jeff Zapletal, Interim Director of Student Leadership and Involvement, to request that the event take place at a centrally located space on campus so it could gain a larger attendance. See Emails between Jack Kentner and Jeff Zapletal, attached as Exhibit A. Given the variety of event spaces near the center of campus, this request was not out of the ordinary. Indeed, the Penn State College Democrats routinely host speakers in Wartick Hall, which is near the center of campus. See College Democrat Flyers, attached as Exhibit B. Mr. Kentner informed Mr. Zapletal that there were several centrally located venues—including but not limited to a room in Wartick Hall—that are available on November 16 that would be suitable for the Lindsay event. See Exhibit A. Despite the availability of these venues, Mr. Zapletal informed Mr. Kentner that the University has "evaluated the event" and has determined that the "BJC is the venue that is available for this event." Id. Mr. Zapletal provided no additional explanation for why the University will not allow the event to take place near the center of campus.

Unfortunately, this is not the first time the University has attempted to suppress Penn State YAF's views on campus. Earlier this year, Penn State YAF was forced to cancel an on-campus event with Dr. Lindsay because then, like now, the University insisted that the event take place at the BJC.<sup>4</sup> Penn State YAF was concerned that attendance for the event would be significantly reduced if it took place on the far side of campus, away from students. Penn State YAF ultimately canceled the event due the University's actions.

#### II. Failure to Provide Equal Access to University Event Space is Unlawful

The University's failure to provide equal access to event space for the Lindsay event would violate the constitutional rights of Penn State YAF and its members. The First and Fourteenth Amendments to the United States Constitution prohibit public universities from discriminating against student organizations based on viewpoint. See Healy v. James, 408 U.S. 169, 184 (1972) ("[S]tate colleges and universities are not enclaves immune from the sweep of the First Amendment."). This prohibition includes failing to provide equal access to limited public fora, Christian Legal Soc'y Chapter of the Univ. of Cal., Hastings Coll. of the Law v. Martinez, 561 U.S. 661, 679 n.11 (2010), and failing to provide equal security for the event based on a discriminatory purpose, see Forsyth County, Ga. v. Nationalist Movement, 505 U.S. 123, 133 (1992). Moreover, the University may not foist security costs onto Penn State YAF. Id. at 134–35. ("Speech cannot be financially burdened, any more than it can be punished or banned, simply because it might offend a hostile mob.").

The campus event spaces available for reservation by RSOs are limited public fora. The University has opened these spaces up to RSOs to host speaking events similar to the Lindsay event. The University routinely allows individuals and organizations with liberal viewpoints to use the event space. See Exhibit B. The University's failure to provide equal access to this event space to Penn State YAF violates the First and Fourteenth Amendment. Martinez, 561 U.S. at 679 n.11; Ne. Pennsylvania Freethought Soc'y v. Cnty. of Lackawanna Transit Sys., 938 F.3d 424, 436 (3d Cir. 2019) ("[T]he government violates the First Amendment when it denies access to a speaker solely to suppress the point of view he espouses on an otherwise includible subject."); Donovan ex rel. Donovan v. Punxsutawney Area Sch. Bd., 336 F.3d 211, 225 (3d Cir. 2003) (observing that public schools "may not discriminate against speech on the basis of viewpoint, and the restriction must be reasonable in light of the purpose served by the forum").

In addition, the University is authorizing a heckler's veto by forcing Penn State YAF to use an inferior venue. See, e.g., Bible Believers v. Wayne Cnty., 805 F.3d 228, 253 (6th Cir. 2015) (en banc). By prohibiting Penn State YAF from using a more centrally located venue due to concerns that some students might react negatively to Dr. Lindsay's speech, the University is engaging in a content-based regulation of speech that must satisfy strict scrutiny. See Ne. Pennsylvania Freethought Soc'y, 938 F.3d at 436 (observing the "heckler's veto" is a content-based restriction on speech). Even if silencing protected speech in the face of a hostile crowd were a compelling government interest, relegating Penn State YAF to the outskirts of campus is not a narrowly tailored way to achieve that interest. The University's actions are therefore unconstitutional.

The University's failure to provide equal access for the Lindsay event is a blatant violation of the First and Fourteenth Amendments that can subject the University and / or its employees to injunctive relief, civil damages, and attorney's fees. *Ne. Pennsylvania Freethought Soc'y*, 938 F.3d



at 436; Intervarsity Christian Fellowship/USA v. Univ. of Iowa, 5 F.4th 855, 867 (8th Cir. 202); 42 U.S.C. § 1988.

### III. The University Must Provide Equal Access to Designated Event Spaces

The University's sustained attempts to exclude Penn State YAF and Dr. Lindsay from speaking at a centrally located event space on campus is an egregious attempt to suppress certain viewpoints among the student body. By forcing Penn State YAF to host its speaker on the far side of campus away from where students typically congregate, the University is reducing the turnout for the event and thereby suppressing what the speaker has to say. Indeed, it appears precluding the Lindsay event from obtaining a large audience is the University's *intended* result. If so, the University's actions would not only be unlawful, but disgraceful.

The Penn State YAF students are at the University to learn. In addition to their studies, they engage with their peers through their student organization to debate the topics of the day. Rather than settling for a life of apathy, these students are involved. Yet the University is treating these students with contempt and disrespect. Such conduct is unacceptable—these students should be commended for organizing this event despite the potential that a hostile mob may attempt to disrupt it.

To avoid litigation, I demand that you notify me, in writing, by 5:00 p.m. Eastern Time on Thursday, November 9, 2023, that you will allow the Lindsay event to take place at one of the venues identified in Mr. Kentner's email to Mr. Zapletal of Thursday, November 2, 2023. See Exhibit A. If Penn State YAF is forced to use an inferior event space due to the University's discriminatory actions, we will have no choice but to institute legal proceedings against the University.




